Roll call was made with all Council Members present except Recorder/Treasurer Dickson.

Minutes from the previous meeting were read and approved with a motion from Council Member Connelly and a second from Council Member Armstrong. Passed 4-0.

The financial report was given and approved with a motion from Council Member Wiley and a second from Council Member Burchfiel. Passed 4-0.

A discussion was held concerning the appointment of a replacement for Council Member Whitaker. Mayor Pyle said Sherman Smith would possibly be interested. He is on the Planning Commission and he would have to resign. Anthony Richards was at the meeting and said he would finish out this term but didn't know if he would run again for the next term. Anthony also ask if the wards were going to be divided by land and also wanted to know if he could have a copy of the City map. Mayor Pyle explained the wards would be divided by population and she also said she would get him a copy of the City map. Mayor Pyle wants to set the wards and discuss the Wards at next months meeting.

Mr. Richards (Anthony's dad) said he was having a problem with his neighbor's dog. The dog gets in his garden and digs up his potatoes and plants. He wanted to know if the City had any laws in place for the type of problem. Mayor Pyle said the City doesn't have anything in place at this time. Mr. Richardson hasn't talked to his neighbor yet but, he will and if this doesn't work he will call the Sheriffs Department.

A discussion was held concerning the 5 acres next to the land the City owns now. The funds just won't be there to buy the land. Mayor Pyle is going to ask the owners if they would hold the land longer than August 2002 but we need to make sure we have the money for the land. Council Member Connelly wants to ask for another year and see if we have the money. He also ask if we can use any of the street fund to buy the land and build storage buildings. If was also suggested to buy half of the land and let the Senior Citizens buy the other half. Mayor Pyle suggested to table the property until next month.

Mayor Pyle said we have about \$30,000.00 in FEMA money we need to spend this month on the roads. She was going to talk to the road crew and get the roads shaped up.

Three Resolutions was presented to the Council for approval. The first Resolution No. 2002-1 was read in its entirety by Council Member Wiley. After no discussion a Motion to adopt was made by Council Member Burchfiel and a second by Council Member Connelly. Passed 4-0.

The second Resolution No. 2002-2 was read in its entirety by Council Member Wiley. Council Member Connelly ask if we needed this Resolution even though we didn't have City law enforcement at this time. Mayor Pyle said yes and suggested we send a copy of the Resolutions to the County Sheriff's office and to the Constable. After no further discussion a Motion to adopt was made by Council Member Connelly and a second by Council Member Armstrong. Passed 4-0.

The third Resolution No. 2002-3 was read in its entirety by Council Member Wiley. Mayor Pyle explained that if during construction of the City Hall, Fire Station, or any other project the City was building, should we harm any home we would have to relocate the home owner and fix the home and move the home owner back home. This will bind us on all construction in the future. After no further discussion a Motion to adopt was made by Council Member Connelly and a second by Council Member Armstrong. Passed 4-0.

A motion was made by Council Member Armstrong and seconded by Council Member Burchfiel to leave all of the County Sales Tax in the General Fund at this time. This motion passed 3-0.

Mayor Pyle said that since we are a Second Class City we have to be divided into Wards. After talking to Don Zimmerman he said 4 Council Members is all that would be necessary. The Mayor talked with Patti Hill and the city has been divided into 2 Wards and each Ward will have 2 positions.

Mayor Pyle gave an update on the Fire Department construction. After meeting with the contractor, and Francille with the Department of Rural Services we hope to have construction complete by July 2002.

Norman McAllister approached the Council about replacing a bridge on Little Bridge Lane. Mayor Pyle said that this was a Red Road and not a City Street; however, she had a petition that he could circulate and request that it be taken in as a City Street. He said he would do this.

Darren Hanson and his wife talked to the Council about a proposed newsletter they would like to start doing for the Cedarville area. They want to give back to the City a nickel on

every newsletter sold. Mayor Pyle said that the City appreciated it but suggested they put it back into the business and welcomed them as a new business to the City.

Wiley Brewer spoke to the Council on the behalf of Mike Medlock who is running for Circuit Judge.

Mayor Pyle announced the Municipal League Convention, which will be held June 19-21 in Little Rock. Mayor Pyle, Jane Dickson, Council Member Armstrong and Council Member Burchfiel will be attending.

Mayor Pyle ask that the Council consider giving City Officials who attend meetings \$25.00 for full day out of town meetings. (i.e. Convention – nothing the first day but \$25.00 for the next 2 days.) A motion was made by Council Member Connelly and seconded by Council Member Burchfiel. Passed 3-0.

With no further business a motion to adjourn was made by Council Member Burchfiel and seconded by Council Member Armstrong. Passed 3-0.
