CITY OF CEDARVILLE CITY COUNCIL MEETING MINUTES August 20, 2019

The regular monthly City Council meeting was called to order by Mayor Mark Isenhower after he declared that a quorum was present. A moment of silence was followed by the pledge of allegiance. Council members present were Alderman Odom, Alderman McClendon, Alderman Breshears and Alderman Johnson.

A motion to approve the July regular monthly meeting minutes was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0

The financial report was presented by Treasurer Sandy Cook. End of July balances for each account were read and the August Financial Report was reviewed. A motion to approve the August Financial Report was made by Alderman Odom and seconded by Alderman Breshears. Passed 4-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported that the department has been trimming trees and brush in preparation for the school buses. The department has been experiencing problems with the dump truck. The Council was made aware of a need for a used single axle dump truck and a small tractor with a backhoe attachment to clean ditches on the roads with chip and seal.

Police Chief Ken Howard reported 24 citizen calls, 5 assists to other agencies, 11 citations, 20 warning citations, 0 alarms answered, 1 accident, 2 arrests, 6 felonies and misdemeanor reports filed, 1 warrant served and 24 complaint reports.

Fire Chief Cody Cooper reported 19 calls since the previous council meeting. Of the 19 calls 17 were medical, 1 was a mutual aid to a District 1 fire and 1 was a vehicle accident. The department currently has 3 firemen who work as full time firefighters for a total of 18 volunteer firefighters. Preparations for the upcoming ISO Fire Suppression Rating Evaluation are complete except for the installation of the 3 new fire hydrants and some ongoing training. The fire hydrants are scheduled to be installed soon and the training has been scheduled. The fire department has received the three vehicle radios that were needed and the thermal imaging camera.

ANNOUNCEMENTS

The 2018 Legislative Financial and Compliance Report has been released. For the fourth year in a row, there were no findings for the City of Cedarville.

Citizens' Day coordinated by Mavis Lawson has been scheduled for October 5, 2019. Hot dogs and hamburgers will be provided by Citizens Bank and Harps. There will be several vendors and games for entertainment.

Fall cleanup is scheduled for October 5, 2019. Two 30 yard dumpsters will be placed inside the red gate beside the fire department. Gates will open at 7 a.m. and will remain open until the dumpsters are full or 5 p.m., whichever occurs first. A list of prohibited items will be provided. Only non-commercial personal household items will be accepted.

PUBLIC COMMENTS

Mrs. Godfrey of Elements Bed & Breakfast announced a couples retreat to be held at her establishment the first weekend in September. They are only taking donations to cover the cost. Any leftover donations will be used at the Cedarville Senior Center for beautification of the grounds.

Resolution # 2019-08-20-01, authorizing the Mayor to sign the annual contract with Cedarville Public Schools for a School Resource Officer, was presented by Mayor Isenhower. A motion to approve Resolution # 2019-08-20-01 was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

Resolution # 2019-08-20-02, authorizing the purchase of three fire hydrants from Cedarville Waterworks for \$13,978.09, was presented by Mayor Isenhower. Harps, Citizens Bank and Cedarville First Assembly are donating \$1200 each to assist with the cost. Mr. Barnett has provided the Right of Way needed for one of the fire hydrants. The Cedarville Water Department will provide the installation at no cost to the city. A motion to approve Resolution # 2019-08-20-02 was made by Alderman Breshears and seconded by Alderman Johnson. Passed 4-0

Resolution # 2019-08-20-03, authorizing the Mayor to reimburse Narberth Fire Department in Pennsylvania for 6 new tires for Engine 2 for \$1956.00, was presented by Mayor Isenhower. A motion to approve Resolution # 2019-08-20-03 was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0

With no further business to discuss, a motion to adjourn was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0
