A motion was made by Alderman McClendon and seconded by Alderman Breshears to amend the June minutes to remove the statement concerning no profit being made and replace it with a Thank You to North Town Sales for the good deal made to the City for the street truck. Passed 4-0

A motion to approve the June regular monthly meeting minutes was made by Alderman McClendon and seconded by Alderman Johnson. Passed 4-0

The financial report was presented by Treasurer Sandy Cook. End of June balances for each account were read and the July Financial Report was reviewed. A motion to approve the July Financial Report was made by Alderman Breshears and seconded by Alderman Johnson. Passed 4-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported that the department has been grading the city roads and are patching the chip and sealed roads where needed.

Police Chief Ken Howard reported 32 citizen calls, 7 assists to other agencies, 16 citations, 23 warning citations, 2 alarms answered, 0 accidents, 7 arrests, 9 felonies and misdemeanor reports filed, and 2 warrants served.

Fire Chief Cody Cooper was unavailable due to his full time job. No report was given for the Fire Department.

ANNOUNCEMENTS

Burn ban and water restrictions have been ordered for the county.

Fall cleanup will be October 1st with two dumpsters placed behind the red gate by the Fire Department.

Ordinance # 2022-07-19-01, repealing Ordinance # 2022-06-21-01 was presented by Mayor Isenhower.

A motion to suspend the reading rules and read once only by title and number was made by Alderman McClendon and seconded by Alderman Breshears. Roll call vote: Alderman Odom – yes, Alderman McClendon – yes, Alderman Johnson – yes, Alderman Breshears – yes. Passed 4-0

A motion to approve Ordinance # 2022-07-19-01 was made by Alderman McClendon and seconded by Alderman Johnson. Passed 4-0 The Ordinance will become effective 90 days from posting.

Ordinance # 2022-07-19-02, setting salaries for elected officials, was presented by Alderman Breshears.

A motion to suspend the reading rules and read by title and number only once was made by Alderman Breshears and seconded by Alderman McClendon. Roll call vote: Alderman Breshears – yes, Alderman Johnson – yes, Alderman McClendon – yes, Alderman Odom – yes. Passed 4-0

A motion to approve Ordinance # 2022-07-19-02 was made by Alderman Breshears and seconded by Alderman McClendon. Passed 4-0

A motion to declare Ordinance # 2022-07-19-02 an emergency was made by Alderman Breshears and seconded by Alderman McClendon. Roll call vote: Alderman Odom – yes, Alderman McClendon – yes, Alderman Johnson – yes, Alderman Breshears – yes. Passed 4-0

With no further business to discuss, a motion to adjourn was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0
