The financial report was presented by Treasurer Sandy Cook. End of May balances for each account were read and the June Financial Report was reviewed. A motion to approve the June Financial Report was made by Alderman Breshears and seconded by Alderman Johnson. Passed 3-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported that the department has been making repairs to the chip and seal on Dorothy Drive. The upkeep on the park and other areas have been maintained when weather permits.

Police Chief Ken Howard reported 15 citizen calls, 2 assists to other agencies, 12 citations, 9 warning citations, 1 alarm answered, 2 accidents, 8 arrests, 9 felonies and misdemeanors reports filed, 5 warrants served and 15 complaint reports.

Fire Chief Cody Cooper was absent due to shift work at his full time job. Mayor Isenhower reported 1 fire and several medical calls.

A motion to approve Ordinance # 2019-06-18-01 was made by Alderman Breshears and seconded by Alderman Johnson. Passed 3-0

A motion to declare Ordinance # 2019-06-18-01 an emergency was made by Alderman Odom and seconded by Alderman Breshears. Roll call vote: Alderman Odom – yes, Alderman Johnson – yes, Alderman Breshears – yes. Passed 3-0 This Ordinance will become effective immediately.

Mayor Isenhower asked the Council to approve a salary pay raise from \$1200 per month to \$1500 per month for Grounds Supervisor Kenneth Brenton. A motion to approve the raise was made by Alderman Odom and seconded by Alderman Breshears. Passed 3-0
