

CITY OF CEDARVILLE
CITY COUNCIL MEETING MINUTES
March 16, 2021

The regular monthly City Council meeting was called to order by Mayor Mark Isenhower after he declared that a quorum was present. A moment of silence was followed by the pledge of allegiance. Council members present were Alderman McClendon, Alderman Breshears Alderman Odom and Alderman Johnson.

A motion to approve the February regular monthly meeting minutes was made by Alderman Odom and seconded by Alderman Breshears. Passed 4-0

The financial report was presented by Treasurer Sandy Cook. End of February balances for each account were read and the March Financial Report was reviewed. A motion to approve the March Financial Report was made by Alderman Breshears and seconded by Alderman Johnson. Passed 4-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported on the installation of the new flagpole. The department has been busy cleaning leaves from ditches and culverts for proper water flow, patching the driveway for the Cedarville Senior Center and placing reflectors on the City Hall driveway.

Police Chief Ken Howard reported 32 citizen calls, 5 assists to other agencies, 11 citations, 12 warning citations, 2 alarms answered, 7 accidents, 4 arrests, 2 felonies and misdemeanor reports filed, and 2 warrants served.

Fire Chief Cody Cooper was absent due to shift work at his full-time job.

Spring Clean-up is scheduled for April 17, 2021. Two 30-yard dumpsters will be placed inside the red gate beside the fire department. Gates will open at 7 a.m. and will remain open until the dumpsters are full or 5 p.m., whichever occurs first. A list of prohibited items will be provided. NEW BUSINESS

Tracee McKenna from WAPPD presented a plan for the application of a Community Development Grant for the Boys and Girls Club to renovate the old Cedarville Elementary cafeteria.

Mayor Isenhower presented Resolution # 2021-03-16-01, participation plan for the Community Development Grant. A motion to approve Resolution # 2021-03-16-01 was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0

Resolution # 2021-03-16-02, prohibiting the use of excessive force by the Police Department as required for the Community Development Grant, was presented by Mayor Isenhower. A motion to approve Resolution # 2021-03-16-02 was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

Mayor Isenhower presented Resolution # 2021-03-16-03, authorizing the Mayor to apply for the ACEDP grant for the Cedarville Boys and Girls Club. A motion to approve Resolution # 2021-03-16-03 was made by Alderman Breshears and seconded by Alderman Johnson. Passed 4-0

Police Chief Howard presented information on the purchase of a used 2017 Ford Explorer Police Interceptor with approximately 70,000 miles from Big Bear Police Vehicles. After discussion the Chief was asked to gather information on other possible vehicle purchases. No action was taken.

Mayor Isenhower reported that the Cedarville Senior Center parking lot improvement has been completed.


The Council requested that a separate gas meter be installed for the Street Department Maintenance Shop. Mayor Isenhower will contact AOG to request one to be installed.


The Council requested the relocation of the security cameras' recording equipment. The equipment will be moved from the Police Department evidence room to the Mayor's office.

Alderman McClendon suggested electronic door locks should be placed on the Police Department and mail drop slots should be placed on the doors of the Police Department, the Treasurer's office and the Mayor's office for confidentiality purposes. A motion to install electronic door locks and mail drop slots was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

Mayor Isenhower asked that the Council approve the sale of the Street Department's 1990 GMC Dump truck. It will be advertised in the newspaper and sealed bids will be taken. A motion to approve the sale of the 1990 GMC dump truck and remove from the City asset list were made by Alderman McClendon and seconded by Alderman Odom. Passed 4-0

With no further business to discuss, a motion to adjourn was made by Alderman Breshears and seconded by Alderman McClendon. Passed 4-0
