DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported that the department has been grading roads, digging ditches, cleaning out culverts, and cleaning up debris caused by the storms. One set of speed bumps have been installed in the Willow Creek subdivision. An additional set will be installed after the rains.

Police Chief Ken Howard reported 34 citizen calls, 4 assists to other agencies, 6 citations, 9 warning citations, 1 alarm answered, 3 accidents, 3 arrests, 7 felonies and misdemeanor reports filed, and 2 warrants served. Three code enforcement warnings were issued.

Fire Chief Cody Cooper reported 1 structure fire call to assist District 4 Fire Department and 3 medical calls.
