CITY OF CEDARVILLE CITY COUNCIL MEETING MINUTES October 15, 2019

The regular monthly City Council meeting was called to order by Mayor Mark Isenhower after he declared that a quorum was present. A moment of silence was followed by the pledge of allegiance. Council members present were Alderman Odom, Alderman McClendon, Alderman Breshears and Alderman Johnson.

A motion to approve the September regular monthly meeting minutes was made by Alderman McClendon and seconded by Alderman Odom. Passed 4-0

The financial report was presented by Treasurer Sandy Cook. End of September balances for each account were read and the October Financial Report was reviewed. A motion to approve the October Financial Report was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton was unable to attend the meeting. Street and Maintenance worker Kelly Lopeman reported that the department has been weed eating on the sides of the roads and filling potholes with cold patch on the chip and sealed roads. Donnie Jones will be called out of retirement temporarily to assist in the winterizing of the street roads.

Police Chief Ken Howard reported 32 citizen calls, 7 assists to other agencies, 9 citations, 15 warning citations, 1 alarm answered, 2 accidents, 6 arrest, 12 felonies and misdemeanor reports filed, 1 warrant served and 32 complaint reports.

Fire Chief Cody Cooper was absent due to shift work at his full time job. Volunteer Kelly Lopeman reported 6 calls, 5 medical calls and 1 grass fire. Firefighter training is ongoing. Two new fire hydrants have been installed and tested. The third hydrant will be installed soon.

NEW BUSINESS

Resolution # 2019-10-15-01, to levy the property tax as 0, was presented by Mayor Isenhower. A motion to approve Resolution # 2019-10-15-01 was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

Resolution # 2019-10-15-02, authorizing the Mayor to accept the bid and pay PAC Printers for markings/decals on fire trucks, was presented by Mayor Isenhower. A motion to approve Resolution # 2019-10-15-02 was made by Alderman Odom and seconded by Alderman Johnson. Passed 4-0

Alderman McClendon expressed concern over the erosion caused by water saturation on the chip and sealed roads. Mayor Isenhower stated that the Street Department plans to clean out the ditches, place rock under the affected areas to build them up and place cold patch on the holes.

The Council again discussed the plan to place on the 2020 November ballot the deannexation of Hightower Road and the City's East portion of Millpond Road from Hightower Road to the County line.

With no further business to discuss, a motion to adjourn was made by Alderman Breshears and seconded by Alderman McClendon. Passed 4-0
