CITY OF CEDARVILLE CITY COUNCIL MEETING MINUTES October 17, 2023

The regular monthly City Council meeting was called to order by Mayor Deborah Pinkerton after she declared that a quorum was present. A moment of silence was followed by the pledge of allegiance. Council members present were Alderman Odom, Alderman McClendon, Alderman Breshears and Alderman Johnson.

A motion to approve the September regular monthly meeting minutes was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0

The financial report was presented by Treasurer Sandy Cook. End of September balances for each account were read and the October Financial Report was reviewed. A motion to approve the October Financial Report was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported the department has been busy working on ditch lines and grading roads. A total of \$52.00 was collected from scrap at the city cleanup.

Police Chief Ken Howard reported 27 citizen calls, 2 assists to other agencies, 2 citations, 7 warning citations, 1 alarm answered, 3 accident, 2 arrests, 8 felonies and misdemeanor reports filed, 0 warrants served and 11 code enforcements.

Fire Chief Cody Cooper reported no fire calls and 5 medical calls. The department responded to one traffic accident and assisted District 4 with an ATV accident. Alderman Breshears asked if the Fire Department was up to code for an ISO inspection. Alderman Johnson stated an inspection was not due for 3 years but the Department is up to code.

A Cedarville City Citizen has asked permission to start a non-comment Facebook page with Cedarville news and activities. The council suggests asking this citizen to place a running ad for part-time employee for the City Street Department.

UNFINISHED BUSINESS

The Fun Park Grant has been denied. The City will apply again next year.

NEW BUSINES

The Mayor asked the Council if the City wishes to impose a city millage for 2024. A motion to not impose a city millage for 2024 was made by Alderman Breshears and seconded by Alderman Odom. Passed 4-0

Mayor Pinkerton informed the council of a concern for a crumbling corner on Willow Creek Drive. It was determined that this can be repaired by City employees. Mayor Pinkerton and Supervisor Brenton have set a schedule to get road projects caught up. This issue will be placed on the schedule.

The Council discussed the need to dispose of one of the fire trucks. A motion to accept sealed bills (minimum bid \$1500) at City Hall by the end of business on November 20 was made by Alderman Breshears and seconded by Alderman McClendon. Passed 4-0

With no further business to discuss, a motion to adjourn was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0
