RESOLUTION NO. ____2025-12-16-02____

A RESOLUTION AUTHORIZING THE SALE OF A FIRE TRUCK TO THE TOWN OF GREASY, OKLAHOMA; AUTHORIZING THE MAYOR AND RECORDER/TREASURER TO EXECUTE NECESSARY DOCUMENTS; AND FOR OTHER RELATED PURPOSES.

WHEREAS, the City of Cedarville, Arkansas (the "City") owns certain municipal personal property consisting of a fire truck that is no longer essential for municipal purposes; and

WHEREAS, the City has received an offer from the Town of Greasy, Oklahoma, acting through the Greasy Fire Department, to purchase said fire truck on the terms and conditions reflected in the Bill of Sale and related sale information provided to the City; and

WHEREAS, the fire truck to be sold is more particularly described as a 1987 Ford N-Series Truck, VIN 1FDXR82AXHWA39679; and

WHEREAS, the agreed purchase price for the fire truck is Fifteen Thousand Dollars (\$15,000.00), payable by check; and

WHEREAS, Arkansas Code Annotated § 14-54-302 authorizes municipalities to sell and dispose of personal property owned by the municipality upon approval of the governing body by written resolution; and

WHEREAS, the fire truck to be sold is still in use by the City but the sale proceeds can be better utilized for different equipment to improve the capabilities of the City's fire department; and

WHEREAS, the City Council of the City of Cedarville finds that the sale of the fire truck to the Town of Greasy, Oklahoma, on the agreed terms, is in the best interests of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CEDARVILLE, ARKANSAS, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes the fire truck described herein to be sold to the Town of Greasy, Oklahoma, acting through the Greasy Fire Department, for the purchase price of Fifteen Thousand Dollars (\$15,000.00).

SECTION 2. The Mayor and the Recorder/Treasurer are hereby authorized and directed to execute the Bill of Sale and any other documents necessary or desirable to effectuate the sale and transfer of the fire truck to the Town of Greasy, Oklahoma, and to take all actions reasonably necessary to carry out the intent of this Resolution.


SECTION 3. Upon completion of the sale, the Recorder/Treasurer is directed to remove the fire truck from the City's fixed asset listing and to ensure that the disposal of the property is properly recorded in accordance with Arkansas law.

SECTION 4. The mayor by her signature below has certified in writing that the fair market value of the fire truck is less than twenty thousand dollars (\$20,000.00).


