

CITY OF CEDARVILLE
CITY COUNCIL MEETING MINUTES
September 20, 2022

The regular monthly City Council meeting was called to order by Mayor Mark Isenhower after he declared that a quorum was present. A moment of silence was followed by the pledge of allegiance. Council members present were Alderman Breshears, Alderman McClendon and Alderman Johnson. Alderman Odom was absent due to illness.

A motion to approve the August regular monthly meeting minutes and the September 12 special meeting minutes was made by Alderman Johnson and seconded by Alderman Breshears. Passed 3-0

The financial report was presented by Treasurer Sandy Cook. End of August balances for each account were read and the September Financial Report was reviewed. A motion to approve the September Financial Report was made by Alderman Breshears and seconded by Alderman McClendon. Passed 3-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported that the department has been mowing, patching roads and performing maintenance on two red sign roads. The department has been unable to get gravel hauled at present. Dwight Cluck hauled away half of the accumulated dirt by the maintenance shop.

Police Chief Ken Howard reported 40 citizen calls, 2 assists to other agencies, 13 citations, 9 warning citations, 2 alarms answered, 3 accidents, 6 arrests, 8 felonies and misdemeanor reports filed, and 1 warrant served. Officer Mask has continued follow-ups for city cleanup ordinance. Chief Howard reported that the dash cams were not functioning.

Lt. Archie Hyatt reported 22 calls. Chief Cooper was absent due to his full time job.

Fall cleanup will be October 1st with two dumpsters placed behind the red gate by the Fire Department.

Mayor Isenhower reported a 20'x20'x8' carport will cost approximately \$3200 and will be purchased from Sallee Steel Structures in Van Buren.



A motion to add an item to the agenda was made by Alderman McClendon and seconded by Alderman Breshears. Passed 3-0


